# FROM ITS BEGINNINGS TO SUCCESSFUL IMPLEMENTATION

- **October 2013** – proposal approved by EACEA
- **February 2014** – 1st International Conference in Maribor and Zagreb Meeting with Master Students
- In Maribor consortium held **first curricula analysis meeting** as starting point in further discussion on joint master programme
- Agreed: **2 master programmes due to different national legislations – course syllabuses preparation started**
- During project's lifetime: several **conferences and project meetings**, four **handbooks** and **two textbooks**, one **academic journal**, one **scholarship mechanism**, one **glossary of legal terms**, one **project book**, several **workshops** and **two advance courses**, five **guest lectures** by EU experts, **two intercoachings...**

# WP.1. CURRICULA DEVELOPMENT IN INTERNATIONAL AND EU LAW

- First curricula meeting took place in Maribor
- Curricula analysis prepared as basis for preparation of syllabuses
- Final draft discussed and approved at Kazan Conference in November 2014
- Five guest lectures held: Voronezh, Tyumen, Kazan and Odessa
- D. Kennedy – workshop on **learning outcomes** in May 2015 in Voronezh – independent evaluation of the master programme
- **INTRODUCTION OF BEST BOLOGNA STANDARDS INTO THE MASTER PROGRAM**





## WP.2. CREATION OF CENTRES FOR EUROPEAN AND INTERNATIONAL LAW „TEMPUS”

- Zagreb, Odessa and Voronezh Tempus centres
- Odessa TC opened in September 2014 *via* Skype – **proof of Project's flexibility even in exceptional circumstances**
- Venues for research and development of careers
- Targeted at master students
- Websites established and regularly updated
- Will ensure sustainability of project's results
- Equipment bought – improvement of study environment for young researchers





# WP.3. CAPACITY BUILDING FOR MASTER TUTORS

- Advance Summer Course in European Market Law – Zagreb, June 2014
- Advance Course in European Company Law – Odessa, November 2015
- Lectures, searching databases and case studies on modern issues of EU integration and EU law
- Enhancing networking among co-beneficiaries
- **Introducing young researchers to contemporary problems of market freedoms**
- **Basis for creation and development of master programme**
- **Handbooks in EU Market Law, EU Citizenship, Provision of Services and System of Legal Remedies - deliverables**





## WP.4. IMPLEMENTATION OF CURRICULA

- Local accreditation has successfully been put in place at all PC universities
- Spring/Summer 2015 - PC universities organised student fairs and selected primary set of students „criteria of excellence”

- **February 2014** – 1st International Conference took place in Maribor – opportunity to meet, opportunity for young researchers to present their PhD thesis
- **November 2014** – 2nd International Conference took place in Kazan – EU integration, WTO, lobbying services, EU state of play, education and research area, intercultural business communication, globalization...
- **March 2016** – 3rd International Conference took place in Zagreb – Digital Single Market Strategy
- **July 2016** - Final International Conference took place in Maribor – Tempus achievements in context of Bologna standards
- **Papers are published in the Journal and all presentations are available for on-line download**

# Last external evaluation report!

„In terms of project management (WP 6), **the coordinators responded flexibly** to external factors (such as the crisis in Ukraine) and internal challenges (such as accreditation requirements in Russia and Ukraine) (for further comments, see last year's implementation report). **In the year 2015, further progress was made with respect to project implementation. Of particular significance** are the steps towards **local accreditation of the master programmes in European and International Law at the National University "Odessa Law Academy", Voronezh university and Kazan university (WP4)**. The new master programmes have been presented at student fairs which were attended by around **200 potentially interested students**. At Voronezh university, twelve students already enrolled at the new master programme. Efforts were made to improve curriculum development in line with the Bologna process (WP 1 and 3). This included, amongst others, the organisation of a methodological workshop on 'writing and using learning outcomes: a practical guide' in Voronezh (May 2015) and an advanced course on European company law in Odessa (November 2015). **The Tempus centra in Zagreb, Voronezh and Odessa are fully operational (WP 2). As far as dissemination is concerned (WP5), all activities of the consortium are regularly published on the project's umbrella website. In addition, the webpages of all co-beneficiary institutions crossrefer to the project's website.** A new issue of the InterEULawEast Journal for International and European Law was published in 2015 and a textbook on European law is in preparation. In terms of project management (WP 6), a project coordination meeting was organised in Riga (March 2015). **In addition, the project coordinator and the co-beneficiary institutions entertain frequent contacts to ensure the smooth implementation of the project. Mechanisms for internal and external quality control (WP 5) are established and function in accordance with the work programme.**”

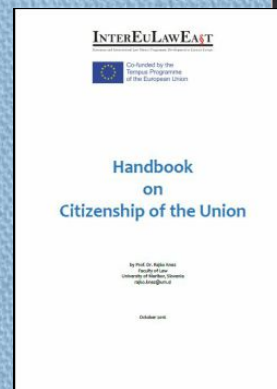


# WP. 8. SUSTAINABILITY

# State of Play of the Project implementation

- In July 2016 the Coordinator asked EACEA to allow the re-allocation of Project's funds left from the ex Latvian partner – Socialo Tehnologiju Augstskola
- Additionally, the Coordinator asked for extension of the Project by 31st May 2017
  - **Due to still on-going activities in terms of dissemination and sustainability**
- Both requests were approved by EACEA in September 2016
- Consequently, the consortium updated the working agenda
- In October 2016 Project coordinator and Zagreb team visited international conference in Odessa
  - Prof. Horak held guest lecture for local students and presentation of the Project to local and international academic community
